ALL PARTICIPANTS WITHIN THE VILLAGE AND WIDOWS PROGRAMS STUDY THE BIBLE. RAFIKI'S WORK IS LOCATED IN ETHIOPIA, GHANA, KENYA, LIBERIA, MALAWI, NIGERIA, TANZANIA, UGANDA, AND ZAMBIA. THESE COUNTRIES HAVE INVITED RAFIKI TO COME TO THE COUNTRIES AND HAVE OFFICIALLY REGISTERED THE FOUNDATION AS AN NGO. EACH VILLAGE HAS A MINIMUM OF SEVEN COTTAGES, FOUR SCHOOL BUILDINGS, A DINING HALL, FOUR MISSIONARY RESIDENCES, THE ADVANCED LEARNING INSTITUTE COMPLEX (THREE BUILDINGS), AND GUEST HOUSE FOR A TOTAL OF TWENTY
